# Motion to approve Agenda by Vern Laning, 2<sup>nd</sup> by Jim Verwey. Motion carried.

**ND DVA Report** – Commissioner Lonnie Wangen [POWER POINT PRESENTATION] - Requested two 100% funded interns. These positions were combined and 1 position approved and will be advertised. The intern will work on our agency's website and social media outlets.

- Calie Lindseth and Summer Kristianson, American Legion VSO, did outreach work in Adams, Bowman, Emmons, McKenzie, and Slope counties. They also met with veterans and helped file claims, along with doing public presentations.

- Ongoing VSO Training with MHA (Three Affiliated Tribes), Standing Rock Sioux Tribe, Sheridan and Cass Counties.

-Update on naming bridges project.

- Vietnam Veterans coins are being handed out throughout the State and are very much appreciated.

- SAA Officer, Chris Kratochvil, attending training at the National Conference. He is working on getting surveys and site visits completed. All catalogs are completed for FFY24.

- Updates on NDDVA Loan Program, Fund 410 (PWTF Clearing Account), and NDDVA Grant Programs.

-988 is designated as the Suicide & Crisis Lifeline, for veterans dial 988 then press 1. Governor is encouraging State Agencies/Higher Education to put the 988 icons on their websites. Governor's Proclamation "Veteran and Military Suicide Prevention and Awareness Year 2024" distributed to committee members.

- Federal Grant awarded to ND Legal Services They will provide legal services for homeless or at-risk veterans. Commissioner Wangen and Trish Hodny met with ND Legal Services and will now partner with them to help veterans. Trish Hodny gave additional information on what types of services can be given to veterans.

-Document Scanning Project to date: 297,283 documents scanned, collected from 41 of the 43 counties participating and tribes plus the state cemetery, completed and returned 5 counties and 1 tribal.

# Gracia Sanchez-Dekarske, Executive Assistant to Dr. Breton Weintraub, Fargo VAHCS Director

- Minimal COVID activity among inpatients and VA staff

-Community Care is a necessary and vital part of what we do. However, it is important to right-size it:

-Some Veterans prefer to get their care with us despite distance

-In many cases, we can get the Veterans in sooner than the private sector -Seeing the Veteran within our healthcare system keeps all their medical records in one place, which is helpful to prevent fragmentation of their care

-Even though we can in most cases retrieve records electronically from other healthcare systems, the process is cumbersome and impedes our clinical staff when trying to do their work

-We continue to face budgetary pressures this fiscal year

-Higher than anticipated growth in Pharmacy expenses

-Continuing growth in Community Care expenditures

-Wage growth across the federal sector and overall growth in our staffing

-We continue to participate and assist with the COMPACT Act. Activity has been steady but not excessive.

Motion by Vern Laning to accept November 2023 minutes, second by Jim Verwey. Ed Ennis recommended the Roll Call vote on the Commissioner's Salary have the names listed. Vern Laning accepted that language as an amendment to his motion, Jim Verwey seconded. Amended motion passed unanimously.

Discussion on next meeting: Motion by Ed Ennis for the next ACOVA meeting to be held May 16 & 17, 2024 in Jamestown, second by Glenn Wahus. Motion passed unanimously.

Chairman Strom spoke on appointments for the North Dakota Veterans Home Governing Board. Kenny Wiederholt name was submitted by Dean Overby for consideration. Jim Verwey reported that Mr. Wiederholt is also the chairman of the Veterans Home Foundation Board. Commissioner Wangen spoke on a conversation he had about having a legislator serve on the Governing Board. There has been a legislator, Judy Lee, who has served in the past. Commissioner Wangen will check with our attorney, Dean DePountis, in the Attorney General's Office to find out if there is a conflict of interest for legislators to serve on the Governing Board.

<u>Veterans Affairs Subcommittee</u> – report by Glenn Wahus Glenn Wahus served as Acting Chairman.

Discussed Policies #404, #412, #413, #604, #612, and #613. Recommend accepting proposed changes for policies #404, #412, #413, #604, and #612. Policy #613 will be discussed at a later meeting.

Discussed upcoming legislation on veterans Aid Loan to increase amount to \$7,500 from \$5,000.

Reviewed budget and that is going well.

Discussion on HRTG funding for increasing staff salaries for additional duties worked on the grant. This would be a flat wage increase.

Motion to accept report by Glen Wahus, second by Hal Weninger. Motion carried. Policy #413 Hardship Assistance Grant - Income Motion by Glenn Wahus to approve raising the Hardship Grant Monthly Net Income Limit to match the VA Monthly Pension rates based on household size, second by Jim Verwey. Motion passed unanimously.

#### Policy #412 Hardship Assistance Grant - Assets

Motion by Ed Ennis to increase the irrevocable burial fund amount to \$8,500, second by Trish Hodny. Motion passed unanimously.

Policy #612 Motion by Trish Hodny to increase the irrevocable burial fund to \$8,500 second by Ed Ennis. Motion passed unanimously.

Policy #404 Hardship Assistance Grant – Cancellation Motion by Glenn Wahus to accept the proposed changes, seconded by Ed Ennis. Motion carried unanimously.

### Policy #604 IMPACT Grant - Cancellation Motion by Glenn Wahus to accept proposed changes, second by Trish Hodny. Motion passed unanimously.

Discussion on compensating Commissioner for additional workload on Highly Rural Transportation Grant (HRTG). The Department was awarded the HRTG eleven years ago (2013) but staff hasn't been compensated for the additional workload of administering the grant. The Commissioner and Chief Administrator have had duties since the grant was awarded. A temporary position was created to administer the program but unfortunately, this position was cut along with two permanent positions by the legislature in 2017. The duties of the temporary worker were shifted back to the Commissioner and staff. The current HRTG included salary funding for a temporary employee and Department staff to receive compensation. The temp works minimal hours and is ineligible for health insurance. One staff member supervises the temp and does additional work on the grant, one staff member handles the administrative work, and the Commissioner oversees the grant funding to include procuring vans, applying for the grant and federal reimbursements. Department employees are aware the additional pay is only available until the yearly grant ends on September 14, 2024. They are also aware that if the temp is able to increase his hours even to the point of getting health insurance, their HRTG pay will be reduced or taken away. The staff pay will be tracked by using coding for temporary salaries and does not affect their regular salary. Commissioner Wangen will be determining the staff increases and it is up the Administrative Committee to determine if Commissioner Wangen should get additional temporary pay.

Motion by Glenn Wahus to authorize NDDVA to expend available Highly Rural Transportation Grant salary funds for temporary salary increase for the Commissioner for work on HRTG program, second by Steve Anderson. Motion carried, with one abstained – Trish Hodny.

#### Legislative Subcommittee – report by Vernon Laning

Discussion on additional items for consideration for the 2025 Legislation Session were discussed with Commissioner Wangen. Reviewed proposals to the Governor's Strategic Plan and recommendations from Department employees for future consideration. Any comments on the Strategic plan or Department recommendations will be forwarded to the Commissioner prior to his March 14, 2024 meeting with the Governor.

#### **Appeals Subcommittee** – report by Dave Hilleren

An Appeal hearing was held on Thursday, February 8 at 4:00pm. The Commissioner denied an Impact Grant because assistance with prepaid funeral expenses does not meet Impact Hardship Assistance Grant criteria 5a. "Must be for an immediate need such as unexpected or emergency expenses which would create an undue hardship or payment of living expenses that are past due because of extenuating circumstances." The Appeals Committee voted to uphold the Commissioner's denial.

# Motion by Dave Hilleren to accept minutes as presented, second by Dave Rice. Motion carried unanimously.

#### *PWTF Subcommittee – report by Trish Hodny*

Subcommittee recommends Veterans Aid Fund amount to be put into CD's.

### Motion by Trish Hodny to allow Commissioner's discretion in determining an amount from the Veterans Aid Loan fund to be put into CDs, second by Steve Anderson. Motion carried unanimously.

There is a request for \$20,000 for PWTF dollars for purchasing Vietnam Veteran Coins. The funding for the PWTF is from the Vietnam Veterans Adjusted Compensation. The coins purchased so far have come from donations. Commissioner Wangen would like to order enough coins to make sure every Vietnam Veteran in the State is given one. If donated funding comes in, it will be used as pay back to the PWTF. Subcommittee recommends approval for the amount requested.

Motion by Dave Hilleren to expend \$20,000 for Vietnam Veterans Welcome Home Coins, second by Trish Hodny. Motion carried unanimously.

# Motion by Trish Hodny to accept the subcommittee report as read, second by Dave Rice. Motion carried unanimously.

#### Chairman Report

Chairman Strom has been attending meetings throughout the State. He talked about a stand-alone machine that will cash in gaming tickets rather than having a cashier handle the pay-outs.
