Cynthia Schlosser – lives in Bismarck, has two sons and six grandchildren. Spent 29.5 years in military as a Nurse. Her last military assignment was serving on a special staff to a two-star General.

Jim Hapala – lives in West Fargo and was on the Veterans Legislative Council for four years. He served in Vietnam. He is married with two kids and worked at one company for forty years. He has been retired for some time.

Jacob Volk – lives in Devils Lake and has two kids. He worked at Montana-Dakota Utilities and served in the National Guard. He rides motorcycle and enjoys fishing.

Chairman Strom asked for a motion to approve the agenda.

Motion to approve Agenda by Dave Hilleren, 2<sup>nd</sup> by Vernon Laning. Motion carried. ND DVA Report – Commissioner Lonnie Wangen [POWER POINT PRESENTATION] Updated committee on the activity of Department Veterans Benefits Specialists for the period of Apr-June 2024. Claims work continues trending upward with the submission of 267 claims and 66 Appeals, with a biennium total so far of 6,469 claims submitted and Retro payments totaling \$16,510,467.15. Outreach interaction included three counties, Turtle Mountain Stand Down and the Spring Training Conference. Funeral Honor Coins can be purchased on-line through the State Historical Society. Donations are coming in to help place bridge signs for the "Bridges for the Fallen". Instead of the families having to pay for the signs, veterans' organizations are sending in funds.

Updates were given on the State Approving Agency, the Department Loan Division, and various programs the Commissioner is involved with such as the Fisher House and 988.

**Jason Petti, Fargo VAHCS Director** – There are 18,000+ unenrolled veterans in North Dakota. He has been doing a large media push trying get veterans to enroll. There have been over 230 flu shots given as of yesterday. Schedule a meeting with MHA Nation representatives (Three Affiliated Tribes) about travel issues. Fisher House update: six to seven properties are being looked at for a site. Properties are within a 5-mile radius of VA Hospital, with one in Moorhead. He will be leaving his post on September 30<sup>th</sup>. The Fargo VA Hospital was rated a 4 STAR facility; veterans get exceptional service at Fargo VA Hospital.

## ND Cares: Michelle Gauvin-Panos, Director

ND Cares has been doing radio ads for the ND Veterans Home and a few other entities; they are now doing ads for Legal Services of North Dakota that is providing support to veterans. She is trying to get training in military culture for mental health providers to help providers understand veteran's backgrounds better. Oil and Gas companies in Watford City put on a mental health event. There were several suicides of their employees who had veterans' status. Discussion on the lack of Tricare behavioral health providers. There will be a Rural Suicide Awareness Summit at the end of September in Minot. ND Cares is working with the VA to do an event in Bismarck during the winter.

## ND National Guard, LTC Sheldon, Adjutant General's Office [POWER POINT PRESENTATION]

U.S. Air Force Brig. Gen. Mitchell Johnson officially assumed command as Adjutant General of the North Dakota National Guard this past weekend. He will also serve as the Director of North Dakota Department of Emergency Services.

FY23 National Guard Economic Impact is at \$315 million dollars. The largest amount is payroll, followed by expenditures and indirect wages and is spread throughout the State. Top five Budget Initiatives: Critical Infrastructure State Match - \$6M, Infrastructure Insurance - \$1.2M, Regional Training Institute Authority - \$34M Federal, Next Generation Leadership Pilot Program - \$1.09M and Williston Readiness Center Design Funds - \$2.5M. Top 4 Policy Initiatives: State Active-Duty Death Gratuity, State Active-Duty Medical Protections, Update Century Code to match Federal Law, and Prevent state from adopting Defend the Guard Legislation.

## Job Service ND – Jerome Billups, Director DVOP & LVRS

There are 12,000 open jobs on the Job Service ND website. The majority of openings are in the larger cities. ND unemployment for nonveterans is at 2.5%, ND unemployment for veterans is 1.1%.

Job Service ND is assisting veterans coming out of prison, so they have the skills and tools needed for employment. This assistance is helping keep the recidivism rate is low. Upcoming job fairs: today in Williston, 25<sup>th</sup> in Devils Lake, and 26<sup>th</sup> in Minot. The first veterans virtual job fair held across the nation is scheduled for November 7<sup>th</sup>. There are currently 1,500 active resumes on Job Service ND website.

# ND Assoc. of County & Tribal Veterans Service Officers; Chris Deery, President, Cass County VSO

A successful Standdown was held on September 11<sup>th</sup> in Fargo; over 300 veterans attended the event. Cold weather gear was handed out and a meal was provided to the attendees. The Outdoor Adventure Foundation is set for October 21-23, 2024. It is a pheasant hunt located in the Fort Ransom, ND area. Fargo VA is giving flu shots. A \$21Million Mental Wellness Recovery Center is set to break ground in Fargo; it will be located on the VA grounds.

## ND Veterans Home Governing Board: Vernon Laning, Chair

Staffing continues to be challenge at the Home.

### ND Veterans Home: Dane Grebel, Administrator

Thanked the committee for their service and the work they do on behalf of veterans. There are 98 beds for basic care and 62 are full and 52 beds for skilled care with 51 beds filled. There is a waiting list for skilled care. To shift more beds to skilled care would require more nursing staff, which isn't feasible at this time. VA doesn't recognize

assisted living care, so veterans go from basic to skilled. In June, there was a Health and Human Services survey. The outcome was two small citations with no life safety citations. In July, VA did their yearly survey. The Home received two citations; one small and the other one was the same as previous year. A VA requirement is a contract needed with all medical providers a veteran comes in contact with, this requires an enormous amount of work from the Veterans Home staff. The ND Foundation golf Tournament had 120 teams and was very successful. A road project is underway to re-do the resident's parking lot, converting it from asphalt to concrete. In September, the resident/family picnic was held at the Home; it has been four years since the last event. It was a beautiful day, and everyone had a very good time.

Tom Ryan asked about a lawsuit that included several members of ACOVA. Mr. Grebel stated was unaware of the lawsuit. Tom asked the Administrator to investigate it and report back to the committee.
